The Centaur Memorial Fund for Nurses Philosophy

The Centaur Memorial Fund for Nurses is dedicated to preserving and maintaining a living Memorial Scholarship in honour and remembrance of nurses who served in the Australian Defence Forces at home and abroad. The Scholarship is dedicated to the promotion and continuing development of knowledge and scholarship in the nursing and midwifery professions.

CENTAUR SCHOLARSHIP AWARD

The Centaur Higher Degree Research Scholarship of **a maximum of \$10,000** is awarded annually to a Queensland nurse or midwife who is undertaking a Professional Doctorate or a Doctor of Philosophy in nursing or midwifery or a related discipline.

Eligibility

To be eligible for the Centaur Scholarship the applicant must at the time of the application and award of the Scholarship:

- 1. Be a resident in Queensland
- 2. Hold an unconditional licence to practice as a nurse or midwife with the Nursing and Midwifery Board, Australian Health Practitioner Regulation Agency (AHPRA)
- 3. Have successfully achieved their Confirmation of Candidature
- 4. Have successfully achieved Human Research Ethics Committee approval from an Australian university
- 5. At March 1st next year, have a minimum of 12 months full time equivalent [i.e. 24 months if part-time] remaining in their candidature
- 6. Be a member of the Centaur Memorial Fund for Nurses (see Membership application form for details.

Assessment

Please provide all the information requested in the application form, and address each criterion listed as one document.

The Education subcommittee of the Management Committee of the Fund initially completes a desk audit of all applications to determine eligibility. Complete applications will be evaluated by an expert panel of senior academics selected from nursing or midwifery programs from Queensland universities. The panel's recommendations will be forwarded to the Management Committee who makes the final decision.

<u>Please note</u>: The Committee's decision is final, and discussion will not be entered into with any applicant.

Applications close on the first business day of December – Friday 1st December.

The scholarship winner will be announced at the Annual General Meeting of the management Committee held in April each year.

CONDITIONS OF THE SCHOLARSHIP

- 1. The value of the Centaur Scholarship is up to **\$10,000** and is disbursed in three payments.
 - 1.1. The **first payment \$5,000** is presented at the time of the announcement of the Award usually at the Annual General Meeting of the Fund.
 - 1.2. The **second payment of \$3,000** will be made the following year upon receipt of evidence of progress via the <u>yearly progress report which is due 1-month prior to the annual general meeting</u>.
 - 1.3. The **final payment \$2,000** will be made upon 1) the successful conferment of the PhD/Professional Doctorate and 2) acceptance of a <u>final project report</u> by the Fund Management Committee. Payment is contingent upon the provision of this evidence.
- 2. The successful applicant is required to provide evidence of progress by submitting:
 - 2.1. an annual progress report (due 1-month prior to the Annual AGM) and
 - 2.2. a final project report on successful conferment of the PhD/Professional Doctorate.
- 3. The successful applicant is required to provide evidence to substantiate major expenditure during the term of the Scholarship, in accordance with the budget submitted at the time of application.
- 4. For auditing purposes expenditure must be substantiated by a Statutory Declaration and itemised in broad categories such as: living expenses; university fees; data collection equipment; teaching or clinical time relief; travel; conference registration; books; and other supplies incurred for your research and in line with your budget.
- 5. The Scholarship is terminated in the event of cessation of the student's candidature, in which case any unspent monies should be returned to the Fund.
- 6. The Scholarship may be suspended if a candidate defers their studies, and continuance will be subject to the decision of the Management Committee.
- 7. Recipients of the scholarship consent to their name and details of their research (e.g. Research title, aims and findings/outcomes/achievements) to be available to the CMFN for future promotions.
- 8. Recipients of the scholarship and Fellows are required to acknowledge the Centaur Memorial Fund for Nurses Higher Degree Research Scholarship in any publications and conference presentations arising from their doctoral studies.
 - For example, the following wording can be added to the Acknowledgement or Fundings section of your manuscript.
 - This study was supported by the Centaur Memorial Fund for Nurses Higher Degree Research Scholarship awarded to [Insert Name]. This Scholarship is dedicated to the promotion and continuing development of the nursing and midwifery professions in honour and remembrance of nurses who served in the Australian Defence Forces at home and abroad.
- 9. Recipients of the scholarship are required to share details of publications and conference presentations arising from their doctoral studies to be included in CMFN newsletters and reporting.
- 10. During their candidature and on completion of the PhD/professional doctorate the successful applicant may be asked to present a summary of their research at the Annual General Meeting (AGM) of the Centaur Memorial Fund for Nurses, the May 14 Annual Commemorative Service and/or another professional forum that may be negotiated by the Centaur Management Committee and the awardee.

- 11. On being awarded a PhD/Professional Doctorate and the Committee's acceptance of the final report, the Scholarship recipient may use the post nominal of Centaur Fellow.
- 12. Centaur Fellows are encouraged to use the post nominal of Centaur Fellow in their professional signature.
- 13. Recipients who fail to complete doctoral studies are not entitled to be known as a Centaur Fellow.
- 14. Centaur Fellows are encouraged to contribute to the ongoing work of the Fund. Such as ongoing membership, nominating to join the Fund Management Committee, attending the Annual AGM and Commemorative Service, assisting with fund raising, and promoting the annual scholarship and Joy Croker Medals.
